### About SEWP V continued

SEWP V offers low prices (generally below GSA schedule prices), a competitive surcharge (0.375%) and the easiest and fastest ordering procedure using pre-competed contracts.

Through SEWP V, agencies can find an exact fit for their needs at the best overall value by choosing the right solutions offered directly by leading hardware and software manufacturers and experienced Government integrators, such as Dynamic Systems, Inc.

SEWP V is composed of 202 Indefinite Delivery Indefinite Quantity (IDIQ) contracts to 148 prime contract holders, both manufacturers and resellers of IT equipment. The contracts were awarded in 5 contract groups - 2 full and open and 3 set-aside competitions. Since all awards were multi-award contracts, Fair Opportunity (refer to FAR 16.505(b)) must be given to all contractors in one or more groups.

### Fair Opportunity Clause

FAR 16.505(b) (1) provides that each contractor shall be given fair opportunity to be considered for each order exceeding \$3,000 and issued under multiple award contracts. The FAR states that the method to obtain fair opportunity is at the discretion of the CO and that the CO must document the rationale for placement and price of each order. Using the SEWP online [Quote Request Tool](#) is the recommended method to assist in this activity and to augment the required decision documentation. The SEWP QRT tool will automatically include the Contract Holders within a selected Group or based on a suggested source.

### Market Research

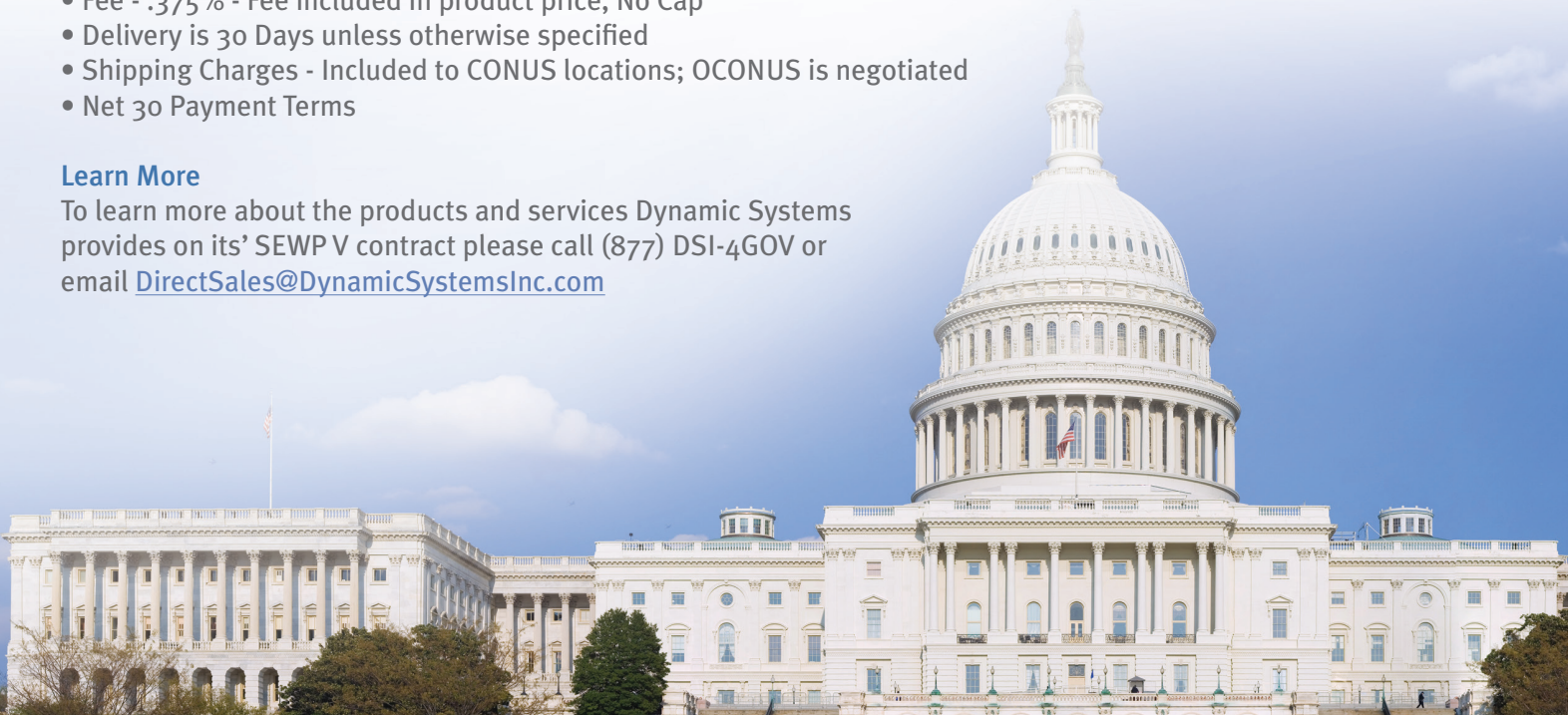
According to Federal Acquisition Regulations, (FAR) Part 10, appropriate market research based on the size and complexity of the acquisition is required. The [Online Quick RFI](#) and [Quote Request](#) SEWP tools assist in this market research process.

- 1) End User or SEWP Contracting Officer
  - Determine best value through market research
  - Create Delivery Order - Cite NASA SEWP Contract Number and Prime Contract Holder
  - Sends Order to NASA SEWP Bowl
  - Obtain ITARS or note exception to ITARS requirement
- 2) NASA SEWP Program Management Office (PMO)
  - Verifies Order
  - Forwards valid order to the appropriate Contract Holder
- 3) SEWP Contract Holder
  - Processes Order
  - Delivers Equipment & Services
  - Invoices Agency or Contractor

SEWP orders must be routed to the NASA SEWP Program Management Office (PMO) either via fax at (301) 286-0317 or [sewporders@sewp.nasa.gov](mailto:sewporders@sewp.nasa.gov). The [SEWP fax cover sheet](#), or similar form providing contact information, should accompany all orders. If modifications are made to any order, these modifications must also route through the SEWP PMO. Orders should not be sent directly to Dynamic Systems.
